Terms and Conditions of Service

1. A non-refundable booking fee of \$250 must accompany this contract. Mares will not be accepted, nor any semen shipped, without completion of the booking form and payment of the booking fee.
2. The service fee is separate from all other fees payable, except for the booking fee which is deductible from the service fee.
3. The balance of the service fee is due within 14 days after the mare produces a live foal.
4. A \$20 overdue fee will be added to overdue accounts on a monthly basis on the first day of each month for which the account is overdue, until full payment is made.
5. All agistment, worming, farrier, vaccination and veterinary costs are the responsibility of the mare owner. These fees must be paid before the mare leaves the stud.
6. The semen collection and shipping fees must be paid by the mare owner prior to each shipment or semen will not be shipped.
7. All costs at destination of semen, including veterinary costs, agistment and handling fees etc, are the responsibility of the mare owner.
8. A breeding certificate / registration application will be issued to the mare owner only after all fees and expenses have been paid in full, and upon notification of the birth of a live foal.
9. There is no live foal guarantee. If the mare does not produce a live foal, or if the foal dies within 48 hours of birth, the mare owner will be not be required to pay the balance of the service fee. Written details of this, from a qualified veterinarian, must be provided to the stallion owner no later than 48 hours after the death of the foal, otherwise the mare owner will be billed for the service fee.
10. The stud owner must be notified of any problems with the mare's breeding history, and reserves the right to reject any mares that are not in good condition physically, or not clean and fit for breeding. Mare owners must submit a current certificate from a qualified veterinarian stating that the mare is fit for breeding otherwise a pre-breeding examination will be conducted by the stallion owner's veterinarian at the expense of the mare owner.
11. The stud owner extends all reasonable care of mares and foals, and reserves the right to employ veterinary care to ensure the full well-being of mares and foals at the owner's cost. Neither the stud owner, nor their employees shall be liable for injury, death or disability suffered by a mare or it's foal, from any cause whatsoever whilst in the care of the stud owner. The mare owner specifically agrees to such conditions and waives each and every claim for damages resulting from such injury, death or disability.
12. It is agreed that should the stallion die or become unfit for service after the booking has been accepted and prior to the mare being confirmed in foal, then the breeding contract will become null and void and the booking fee will be refunded in full. This does not include any agistment, veterinary, collection, or shipping expenses that have been incurred.
13. If for any reason a booking is to be cancelled, please notify the stud as soon as possible.
14. Please refer to the list of fees and charges for breeding, agistment and veterinary services.
